This year marks the 38<sup>th</sup> annual In The Streets, Frederick's favorite block party!

The planning committee is excited to announce that this year the festival will be held the second Saturday in September, **Saturday, September 12<sup>th</sup>, 11 AM – 5 PM.**

In The Streets offers a variety of activities – music, food and fun for all! In an effort to showcase the many wonderful organizations operating in Frederick County, the Committee is happy to invite you to participate.

**NEW** – The Creek Side Market, now the Artisan Block, will be located between Third and Fourth Street in place of the Lifestyles Block. In addition to the Artisan Block, the festival is divided into the following themed areas: Sports, Art, History, Health & Wellness, Lifestyle, Going Green, Public Safety and Kids Blocks. An outline of these areas, including locations, is attached. Please review this prior to submitting your application for participation. Groups will be asked to select the area of the event that is most appropriate for their organization.

**Please be aware that for profit organizations are invited to participate with an approved activity that fits into a themed block and provides an enhancement to the event.** Depending on your planned activity and your business type, you will be assigned a location within one of our themed blocks. Please note your preference of block location on the application form. *NOTE – Final approval and block placement is at the discretion of the In The Streets Committee*

**Please be aware that no sales, fundraisers or distribution of food or beverages may be conducted at this event unless explicitly approved by the In The Streets Committee.** Active solicitation and proselytizing are not permitted, as the Committee wants your information to be available for pick-up, but not a deterrent to attendees.

Participants may choose to reserve a 10' x 10' area in which to display information and provide a small activity, or a 10' x 20' space in which to provide a larger activity throughout the day. Please indicate on the enclosed form the amount of space that you will need. Cost for participation is:

TO ENSURE PLACEMENT IN YOUR DESIRED LOCATION, PLEASE RETURN THE REGISTRATION FORM AND FEE AS SOON AS POSSIBLE!**

If you choose, you may rent a 6’ table and two chairs from the committee for \$20. Please indicate your rental needs on the Participation Form. ***Electricity will not be available at the booths.***

Participants may bring canopies to place over their display however, tent sides are strongly discouraged. Tent sides block a visitor’s view of the businesses located along Market Street. Please note on your application if you intend to bring a canopy, a tent with sides or neither. Participants utilizing a tent with sides will be placed in front of vacant buildings or businesses that are closed.

When considering participation, please be aware that absolutely no vehicles are permitted on Market Street, between All Saints and Seventh Streets, between the hours of 8:30 AM – 6:30 PM. When setting up supplies in the morning, all participants must keep belongings within the width of a parking space until the Market Street Mile is complete, at approximately 10:00 AM. Finally, all supplies must be removed from the street by 5:45 PM to accommodate street sweepers. If you feel that you are unable to meet these guidelines, please refrain from applying to participate in this festival.

### **Sports Block** – *Carroll Creek to Patrick Street*

This block is filled with fun activities that test attendees' athletic ability, such as putt-putt golf, basketball shoot out and other great games.

- Operational from 11 AM to 5 PM
- Vehicles must be off Market Street by 8:30 AM

### **Art Block** – *Patrick to Church Streets*

This block highlights the talents of local performing and creative arts groups. Live entertainment is provided throughout the day on the Art Block Dance Floor, located at the intersection of E. Church & N. Market Streets.

- Operational from 11 AM to 5 PM
- Vehicles must be off Market Street by 8:30 AM

### **History Block** – *Church to Second Streets*

This block will showcase the rich historical heritage of Frederick County. Area museums will offer demonstrations and living histories will be highlighted.

- Vehicles must be off Market Street by 8:30 AM

### **Health & Wellness Block** – *Second to Third Streets*

Local groups encouraging a healthy lifestyle are featured in this block.

Artisans are invited to sell their handmade treasures. In addition, Downtown Frederick merchants not located on Market Street are invited to sell their merchandise.

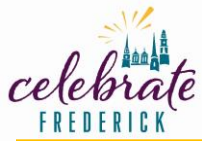
- Operational from 11 AM to 5 PM
